ESL 95P PRONUNCIATION

Credit Hours: 3 Lec 3

PREREQUISITE: ESL Level 2

COURSE DESCRIPTION

This course provides students with an opportunity to improve their comprehension and production of the sound system in North American English. Students will be exposed to a variety of concepts and techniques designed to increase competence in these areas. Special emphasis will be placed on the areas of difficulty for speakers of languages represented in the class.

1. COURSE GOAL

The goals of this course are to improve intelligibility and perception at the segmental (vowels and consonants) and suprasegmental (stress, rhythm, and intonation) levels.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 distinguish between sounds and patterns.
- 2.2 apply rules for predicting vowel and consonant sounds (including final -s and -ed), stress, and intonation.
- 2.3 produce elements of fast speech such as blending, trimming, and vowel reduction.

3. METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with audio-lingual and natural approach
- 3.2 Use of technology, blackboard, and audio materials for presentation, practice, and reinforcement of target sounds and patterns
- 3.3 Oral repetition, substitution, and transformation drills
- 3.4 Written reinforcement of selected structures
- 3.5 Supplementary reading materials
- 3.6 Recording student performances to demonstrate and determine degree of improvement

4. LEARNING ACTIVITIES

- 4.1 Listening to audio materials for pronunciation models and global comprehension
- 4.2 Drills involving minimal pairs, substitution, and transformation for purposes of perception and production
- 4.3 Exercises involving the discovery and prediction of rules
- 4.4 Repetition of target sounds
- 4.5 Dictations
- 4.6 Meaningful and communicative activities requiring extended discourse
- 4.7 Group and pair work for role-plays and information gap exercises
- 4.8 Problem solving

5. EVALUATION

- 5.1 Attendance is mandatory
- 5.2 Class participation
- 5.3 Assignments
- 5.4 Student mastery of materials via in-class activities and evaluations

5.5 Unit exams, quizzes, and a final will be given

6. STUDENT RESPONSIBILITIES
