ESL 95V: ACADEMIC VOCABULARY

Credit Hours: 3 Lec: 3

PREREQUISITE: Eligibility for ESL Level 4

COURSE DESCRIPTION

This course is designed to expand the academic vocabulary of users of English as a second language at the high-intermediate and advanced levels. Emphasis will be placed on the meaning and use of lexical terms in context from a variety of academic fields.

1. COURSE GOAL

The goal of this course is to further develop vocabulary skills for academic purposes.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the role a word plays in a sentence (noun, verb, adjective, adverb, etc).
- 2.2 infer the meaning of terms using context clues and word parts (roots, prefixes and suffixes).
- 2.3 determine the dictionary definition that best fits the use of a term within a specific academic text.
- 2.4 use the correct form of a word (noun, verb, adjective or adverb) in context.
- 2.5 paraphrase the meaning of terms using synonyms, antonyms, examples, and varied sentence structure.

6. STUDENT RESPONSIBILITIES
