EXW150 NUTRITION FOR EXERCISE AND SPORTS

Credit Hours: <u>2</u> Lec <u>2</u>

PREREQUISITE: None

COURSE DESCRIPTION

This course covers the basic principles of nutrition and the interactions between nutrition and fitness training. Topics include dietary practices and nutrient intake modifications that affect physical performance, including intake of energy nutrients, vitamins, water, electrolytes, and dietary supplements. It also covers the study of body weight and body composition, as well as factors that affect body weight and the effect of the body composition on physical performance.

1. <u>COURSE GOAL</u>

Develop understanding of the relationship between nutrition and performance.

Upon satisfactory completion of this course, students will be able to:

- 2.1 recognize physiological demands of varying levels of physical activity..
- 2.2 analyze fluid intake needed for various levels of physical activity
- 2.3 List nutritional requirements necessary for sports related activities.
- 2.4 Describe the relationship between diet and training for optimum performance.
- 2.5 Discuss current theories related to weight gain and/or loss and peak performance.
- 2.6 Discuss the pros and cons of supplements.
- 2.7 Describe the importance of timing when it comes to eating and fluid intake for optimal performance.
