PREREQUISITE: EXW 214 and EXW216 and EXW 218 and EXW 225

COURSE DESCRIPTION

Follows the current American College of Sports Medicine (ACSM) guidelines for health appraisal, risk assessment, safety of exercise, exercise testing, and exercise prescription.

Learn the recommended procedures for exercise testing and exercise prescription in healthy and diseased individuals.

6. STUDENT RESPONSIBILITIES
