## FAS 207 CULTURAL COMPETENCY AND FAMILY ASSESSMENT

PREREQUISITE: FCS 206

#### **COURSE DESCRIPTION**

Understanding various cultures and diversity, basic principles of strength-based assessment and building mutually respectful relationships with families.

## 1. COURSE GOAL

The Family Development Training and Credentialing Program (FDC) provides frontline workers with the skills they need to empower families to attain a healthy self reliance and interdependence with their communities.

## 6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
