FDI 205 EXPLORATION OF GLOBAL FASHION Credit Hours: 2 to 4 Lec 2 to 4

PREREQUISITES: FDI 100, FDI 101, FDI 105, FDI 106, FDI 115, and instructor permission NOTE: Students will be responsible for all academic and institutional fees, travel, lodging, and personal experiences, including but not limited to required textbooks and other program-specific materials.

COURSE DESCRIPTION

This course will allow students with a sufficient academic background who wish to investigate and/or expand their knowledge of the fashion industry in an international environment and receive a global perspective on industry practices and methods. This learning experience is designed to allow students opportunities such as but not limited to taking courses at other institutions, internships, or independent studies.

6. <u>STUDENT RESPONSIBILITIES</u>

6.1 Under AWC Policy, students are expected to attend every session of class in which they
