FDI 205 EXPLORATION OF GLOBAL FASHION

Credit Hours: 2 to 4 Lec 2 to 4

PREREQUISITES: FDI 100, FDI 101, FDI 105, FDI 106, FDI 115, and instructor permission

NOTE: Students will be responsible for all academic and institutional fees, travel, lodging, and personal experiences, including but not limited to required textbooks and other program-specific materials.

COURSE DESCRIPTION

This course will allow students with a sufficient academic background who wish to investigate and/or expand their knowledge of the fashion industry in an international environment and receive a global perspective on industry practices and methods. This learning experience is designed to allow students opportunities such as but not limited to taking courses at other institutions, internships, or independent studies.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they

are enrolled.

- 6.2 Classroom Assignments: Students are responsible for the work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
- 6.3 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.

To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for "No Show" reporting during the first 10 days of each semester. Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.
