FIN 220 FUNDAMENTALS OF INVESTING Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: FIN 100

COURSE DESCRIPTION

Fundamentals of investing will revolve around developing, implementing, and monitoring a diverse investment program, which includes the introduction to topics and techniques used by both personal investors and money managers.

- 1.1 Identify the investment environment, securities market and securities transactions.
- 1.2 Evaluate risk and return, time value of money, and the portfolio concept.
- 1.3 Analyze common stocks, market efficiency, and behavioral finance.
- 1.4 Examine fixed income securities and bond valuation.
- 1.5 Understand mutual funds, exchange-traded funds, and portfolio management.
- 1.6 Understand derivatives, options, commodities, and financial futures.
- 1.7 Examine the effects of taxation on capital gains and dividends.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the financial markets, investment trading, and types of traders.
- 2.2 distinguish between common stock, preferred stock, bonds, mutual funds, convertible securities, hedge funds, exchange-traded funds, options, and futures.
- 2.3 apply the time value of money concepts in various financial scenarios.
- 2.4 establish investment goals and objectives.
- 2.5 apply the steps in the investing process.
- 2.6 adopt, evaluate, construct, and manage a portfolio of diversified securities.
- 2.7 evaluate taxation of securities, capital gains, and ordinary income.
- 2.8 access tax advantage retirement plans, investing over the life cycle, and investments in the business cycle.
- 2.9 analyze short term liquidity needs

6. <u>STUDENT RESPONSIBILITIES</u>
