FRE 095 BEGINNING CONVERSATIONAL FRENCH 1

Credit Hours: 3 Lec 3

PREREQUISITE: None

COURSE DESCRIPTION

Basic communication skills with emphasis on oral communication and pronunciation. Grammar is taught only as it will facilitate conversation.

1. COURSE GOALS

- 1.1 Listening Comprehension: Student will demonstrate ability to understand the spoken French language through use of tapes.
- 1.2 Speaking: Student will demonstrate ability to speak the French language to the extent of carrying on a simple conversation.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 communicate in highly predictable everyday situations.
- 2.2 process and replicate oral information at low novice level.
- 2.3 produce limited memorized material in simple statements or questions.
- 2.4 demonstrate understandable pronunciation skills when speaking.
- 2.5 recognize and explain everyday cultural patterns.
- 2.6 present and articulate personal information.
- 2.7 act appropriately in common everyday situations.

3. METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Discussions, readings, repetition of phrases, role playing, and oral and written drills
- 3.3 Filmstrips and realia
- 3.4 Analysis for home study
- 3.5 Any other supplementary or unique method of instruction by instructor could be used as long as the major objectives are met

4. LEARNING ACTIVITIES

- 4.1 Student will study the textbook
- 4.2 Student will view filmstrips, slides, pictures
- 4.3 Student will take oral and written quizzes and tests
- 4.4 Student will work in groups in classroom
- 4.5 Student will execute commands in class
- 4.6 Student will do all homework assigned and participate in class discussions

- 5.2 Written work
- 5.3 Unit papers once a month
