FRE 096 BEGINNING CONVERSATIONAL FRENCH 2

Credit Hours: 3 Lec 3

PREREQUISITE: FRE 95

COURSE DESCRIPTION

A continuation of FRE 95. Basic communication skills with emphasis on pra; communication. Grammar is taught only as it will facilitate conversation.

1. **COURSE GOALS**

- Listening comprehension: Student will demonstrate ability to understand the spoken French language by passing proficiency listening tests.
- 1.2 Speaking: Student will demonstrate speaking ability in French by carrying on a conversation with classmates.

2. **OUTCOMES**

Upon satisfactory completion of this course, students will be able to:

- 2.1 communicate in highly predictable everyday situations.
- 2.2 process and replicate oral information at novice level.
- 2.3 produce memorized material in simple statements or questions.
- 2.4 demonstrate understandable pronunciation skills when speaking.
- 2.5 recognize and explain everyday cultural patterns.
- 2.6 present and articulate personal information.
- 2.7 act appropriately in common everyday situations.

METHODS OF INSTRUCTION 3.

- 3.1 A Total Physical Response (TPR) is used along with audio-lingual and natural approach
- 3.2 Discussions, readings, repetition of phrases, role playing of dialogues, and oral drills are used
- 3.3 **Filmstrips**
- 3.4 Any other supplementary, or unique method of instruction by instructor could be used as long as the major objectives are met

LEARNING ACTIVITIES 4.

- Student will study textbook 4.1
- 4.2 Student will take oral and listening quizzes and tests
- 4.3 Students will work in groups in classroom
- 4.4 Students will do all homework assigned and participate in all classroom discussions
- 4.5 Student will view filmstrips on French culture

5. **EVALUATION**

- 5.1 A test after each chapter, midterm, and a final comprehensive (oral, aural, written, reading) is required
- 5.2 Participation
