## FRE 102 ELEMENTARY FRENCH 2/GE

Credit Hours: 4 Lec 4

PREREQUISITE: FRE 101 or FRE 116 or 1 year of high school French or interview with instructor

## COURSE DESCRIPTION

A continuation of FRE 101. Basic communication skills with emphasis on oral skills and elementary grammar.

Fulfills the second semester foreign language requirement at most four-year institutions.

## 1. COURSE GOALS

- 1.1 To continue building on listening and speaking skills initiated in Elementary French 101.
- 1.2 To continue developing reading comprehension and improve writing skills.
- 1.3 To present traditions and cultures of French speaking.
- 1.4 To provide an atmosphere that will generate more interest in continuing the study of French.
- 1.5 To develop ethnic, race, and gender awareness.

## 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify important facts in a text through reading.
- 2.2 supply simple biographical information on forms.
- 2.3 write simple paragraphs using familiar material.
- 2.4 recognize and explain everyday cultural patterns.
- 2.5 demonstrate understandable pronunciation skills when speaking.
- 2.6 engage in conversation, provide and obtain information, express feelings and emotions, and exchange opinions in highly predictable everyday settings.
- 2.7 process and replicate written and spoken language on a limited variety of topics.
- 2.8 present information, concepts and ideas to an audience of listeners or readers on a limited variety of topics.

## 4. METHODS OF INSTRUCTION

- 4.1 Total Physical Response (TPR), along with the audio-lingual and natural approach

- 4.3 Cultural filmstrips and videotapes
- 4.4 Small group and class discussions
- 4.4 Any supplementary or unique method of instruction could be used by the instructor as long as the major objectives are met

- 5.2 Assigned exercises
  - 5.3 Execution of command forms of verbs
  - 5.4 Cultural filmstrips and videotapes

  - 5.7 Class discussions and lectures
6. EVALUATION
- 6.1 A test after each chapter, midterm, plus a final comprehensive exam (oral, aural, written, and reading comprehension)
  - 6.2 Class participation
  - 6.3 Quizzes and written assignments
  - 6.4 The percentage of points given to each of the above sections is left to the discretion of the instructor
7. STUDENT RESPONSIBILITIES
- 7.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
  - 7.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor.
