PREREQUISITES: FRE 102 or interview with instructor and ENG 101 eligibility or completion of RDG 121 or appropriate reading score

COURSE DESCRIPTION

A continuation of French 102 with emphasis on oral communication. Listening and reading comprehension, with writing exercises, are integrated to develop and reinforce intermediate speaking skills. Modern-day topics for discussion provide a conversational approach to learning French. Fulfills the third semester foreign language requirement at most four-year institutions.

- To continue building on listening and speaking skills presented in Elementary French 101-102. 1.1
- 1.2 To continue developing reading comprehension and improve writing skills.
- 1.3 To present modern-day topics and everyday activities for discussion.
- 1.4 To continue presenting the activities, culture and traditions of the French-speaking world.
