### FSC 109 HAZARDOUS MATERIALS CHEMISTRY

Credit Hours: 3 Lec: 3

PREREQUISITE: None

#### **COURSE DESCRIPTION**

Course provides basic chemistry relating to the categories of hazardous materials including recognition, identification, reactivity, and health hazards encountered by emergency services.

#### 1. COURSE GOAL

Provide the student with the basic skills to understand hazardous materials that may be encountered.

- 2.5 describe the basic chemical and physical properties of gases, liquids, and solids.
- 2.6 discuss the nine U.S. Department of Transportation hazard classes and their respective divisions.
- 2.7 demonstrate the utilization of guidebooks, MSDS, and other reference materials to determine an initial course of action.
