FSC 201 FIRE PROTECTION SYSTEMS

Credit Hours: 3 Lec: 3

PREREQUISITE: FSC 152 and MAT 105 or higher

COURSE DESCRIPTION

Course provides information relating to the features of design and operation of fire alarm systems; water-based fire suppression systems, special hazard fire suppression systems, water supply for fire protection and portable fire extinguishers.

1. COURSE GOALS

- 1.1 Identify and describe various types of fire protection systems
- 1.2 Describe the basic elements of a public water system as it relates to fire protection

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 explain the benefits of fire protection systems in various types of structures.
- 2.2 describe the basic elements of a public water supply system including sources, distribution networks, piping and hydrants.
- 2.3 explain why water is a commonly used extinguishing agent.
- 2.4 identify the different types and components of sprinklers, standpipe and foam systems.
- 2.5 review residential and commercial sprinkler legislation.
- 2.6 identify the different types of non-water based fire suppression systems.
- 2.7 explain the components of a fire alarm system.
- 2.8 identify the different types of detectors and explain how they detect fire.
- 2.9 describe the hazards of smoke and list the four factors that can influence smoke movement in a building.
- 2.10 discuss the appropriate application of fire protection systems.
- 2.11 explain the operation and appropriate application for the different types of portable fire protection systems.

6. STUDENT RESPONSIBILITIES
