FSC 250 FIRE GROUND MANAGEMENT

Credit Hours: 3 Lec 3

PREREQUISITE: FSC 204

COURSE DESCRIPTION

Course will introduce fire service personnel to tactical principals that will enhance their ability to successfully terminate typical incidents related to the fire ground. This class will expose students to complex personnel deployment and physical resource development.

1. COURSE GOALS

- 1.1 Expose students to the need for an organized approach to the management of emergency incidents
- 1.2 Familiarize the student with the Incident Command System
- 1.3 Present command staff functions and applications
- 1.4 Familiarize the student with Incident Command System exercises
- 1.5 Introduce the Integrated Emergency Management System

Upon satisfactory completion of this course, students will be able to:

- 2.1 recognize the need for an organized approach to managing emergency incidents.
- 2.2 explain the elements of the Incident Command System.
- 2.3 identify the function of each element of the Incident Command System.
- 2.4 identify Command Staff functions and applications.
- 2.5 explain the Integrated Emergency Management System.
- 2.6 apply the Incident Command System and the Integrated Emergency Management System in simulated and/or written scenarios.

6. STUDENT RESPONSIBILITIES
