FSH 105 FASHION POP CULTURE

Credit Hours: 2 Lec: 2

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to pop culture and the impact on fashion and style, exploring different genres, and where style and fashion were impacted by political, historical, media, and social media.

1. COURSE GOAL

- 1.1. Attain a basic understanding of pop culture and its impact on trends
- 1.2. Gain a new perspective on the relationship between popular culture in Europe and How American and Western culture has impacted global fashion
- 1.3. Analyze how film and television influence fashion forecasting and trend cycles
- 1.4. Analyze the transition from television and film to social media and how this impacts fashion forecasting

6. STUDENT RESPONSIBILITIES
