GEO 102 Introduction to Human Geography

Credit Hours: $\underline{3}$ Lec $\underline{3}$

PREREQUISITE: None

COURSE DESCRIPTION

An introduction to the systematic study of patterns and processes that have shaped human understanding, use, and alteration of Earth's surface. This course uses spatial concepts and landscape analysis to examine human socioeconomic organization and its environmental consequences.

1. <u>COURSE GOALS</u>

- 1.1 Interpret maps and analyze geospatial data.
- 1.2 Understand and explain the implications of associations and networks among phenomena in places.
- 1.3 Recognize and interpret the relationships among patterns and processes at different scales of analysis.
- 1.4 Define regions and evaluate the regionalization process.
- 1.5 Characterize and analyze changing interconnections among places.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the historical development of and common approaches to the discipline of geography as it relates to spatial concepts.
- 2.2 describe features of the physical environment, including earth-sun relationships, the atmosphere, the hydrosphere, the biosphere, and the lithosphere.
- 2.3 explain the processes by which population is measured and analyzed, and identify governmental and individual policies toward population.
- 2.4 describe and exemplify types and causes of migration.
- 2.5 explain features of human culture, including language, religion, and secular customs.
- 2.6 define and exemplify the concept of political geography.
- 2.7 explain characteristics of economic development as they relate to human geography.
- 2.8 explain common agricultural methods and their relationship to human geography.
- 2.9 describe patterns of urban development as they relate to human geography.
- 2.10 describe the uses of natural resources and the resulting environmental concerns and challenges.
