GLG 110 ENVIRONMENTAL GEOLOGY/GE

Credit Hours: 4    Lec 3    Lab 1

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to geologic studies and their application to current environmental problems like waste disposal, land use, and shrinking resources, their causes and possible solutions. Focuses on surface geologic processes and geohazards, natural resources, and global systems. Several local field trips will be included.

- 1.1 Evaluate and critique processes that actively shape the Earth's surface.
- 1.2 Acquire an awareness of local and global relevancy of geologic principles and their impact on human society.

Upon satisfactory completion of this course, students will be able to:

- 2.1 understand the fundamental geologic principles that shape the Earth's surface.
- 2.2 recognize the impact of geology on human society.
- 2.3 convert between and among metric units.
- 2.4 develop scientific hypothesis regarding geologic processes and design simple tests to test the hypothesis.
