GLG 225 INTRODUCTION TO PALEONTOLOGY Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>2</u>

PREREQUISITE: GLG 101 or 102 or BIO 181

COURSE DESCRIPTION

Basic paleontological principles; classification of fossils, their occurrence, geologic distribution, and evolution.

1. <u>COURSE GOALS</u>

- 1.1 Be introduced to the organic history of the earth.
- 1.2 Learn the processes by which paleontologists investigate and interpret the fossil record.
- 1.3 Gain a better understanding of the organization and classification of fossils.

- 2.1 identify and recognize major fossils of animals and plants and understand their classification and evolution.
- 2.2 make comparisons of fossils between different continents and understand how fossils apply to the plate tectonic theory.
- 2.3 understand the inter-relationships between paleontology and other areas of science.
- 2.4 recognize various types of fossil preservation.
- 2.5 be prepared with a basis of geologic study so that they can, if they choose, enroll in more advanced courses in geology or related disciplines in biology or anthropology.
