GME 122 PYTHON PROGRAMMING

PREREQUISITE: MAT 151 or higher level math

COURSE DESCRIPTION

This course will provide a hands-on introduction to the Python programming language with a focus on practical applications and projects. Students will design and build software to solve problems from various disciplines each week using Python packages, data structures, object-oriented programming.

1. <u>COURSE GOAL</u>

Apply the designs and concepts of object- oriented programming for developing (including 3rd party Python packages), debugging, and documenting programs written in the Python language.

Upon satisfactory completion of this course, students will be able to:

- 2.1 Familiarity with the Python programming language and associated development tools (IDEs, pip)
- 2.2 Hands-on experience using various Python data structures, and reading and writing files in Python
- 2.3 Experience with Object-Oriented design in Python, including polymorphism
- 2.4 Experience leveraging powerful 3rd party packages for Python, as well as creating your own custom Python packages for reuse and distribution
