GME-224 SPECIAL PROJECT

Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: GME 100, GME 101, GME 105, GME 110, and GME 112

COURSE DESCRIPTION

To apply core game design skills needed for successful game development: communication, collaboration, affinity of learning, scope, logical thinking (realistic), lateral thinking and breadth of knowledge in a group setting to develop a game from start to end.

1. <u>COURSE GOAL</u>

Work as a group through the process of developing a video game. Create a concept game along with the storyboard, script, artwork, sound, and code samples to successfully demonstrate knowledge of the development life cycle of video games.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate the skill of communication and collaboration: creative writing, technical writing, public speaking, listening, brainstorming and management.
- 2.2 Demonstrate the understanding of scope. Be capable of creating realistic design plans, and the willingness to cut even the parts you personally love the most, in service of the project.
- 2.3 Demonstrate the skill of logical thinking (reasoning mathematics).
- 2.4 Display a breath of knowledge of the arts (arts, sociology, anthropology, psychology etc.) as it applies to inclusion of video game elements.
