GRA 102 GRAPHIC COMMUNICATIONS 2

Credit Hours: 4 Lec 3 Lab 2

PREREOUISITE: GRA 101

COURSE DESCRIPTION

This course (the second semester continuation of GRA 101) will provide an overview of traditional commercial graphics technologies and theory which the students will need for commercial graphics employment. Subjects include basic design theory (gestalt, compositional techniques, such as contrast, repetition alignment, proximity, etc.), simple drawing skills, illustration techniques, pigment and light color theory and physics, production processes and technologies, printing issues, typography, researching a graphic design project, preparing thumbnail sketches, preparing roughs and comps., encouraging productive client communications, and more.

1. **COURSE GOAL**

Become familiar with the basic design issues and skill set necessary to produce professional quality graphics work.

2. **OUTCOMES**

Upon satisfactory completion of this course, students will be able to:

- 2.1 produce the basic steps of the design process.
- 2.2 employ intermediate observational sketching techniques.
- 2.3 identify and discuss the parameters of type design.
- 2.4 employ both simple and complex grid systems in page composition.
- 2.5 identify elements of contrast, repetition, alignment and proximity in a design.
- 2.6 be able to articulate the difference between subtractive and additive color, spot and process color, display and print color models, and other obstacles to color consistency and matching.
- 2.7 create storyboards for interactive and linear presentations..
- 2.8 define the differences between print and interactive graphics
