### ARIZONA WESTERN COLLEGE SYLLABUS

GRA 105 DIGITAL IMAGING 2 Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>2</u>

### PREREQUISITE: GRA 104

#### **COURSE DESCRIPTION**

This course guides students to an intermediate level of image editing using digital imaging software. The course will focus on understanding issues of more complex image manipulation and composing using filters, calculations, actions, channels, layers, and other advanced topics.

# 1. COURSE GOAL

Develop a strong working knowledge of digital imagery, its commercial applications, and a basic understanding of the design issues inherent in composing an effective, eye-catching, and attractive image.

### 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 produce an image following the basic steps of the design process.
- 2.2 employ intermediate observational sketching techniques.
- 2.3 identify and discuss the function of "blend-if-sliders", channels, individual filters, the calculations dialog box, blending modes, and other complex tools for image manipulation and composing within the application environment.
- 2.4 critique the effectiveness and potential improvements of their own work and others.
- 2.5 create images suitable for inclusion in WebPages.
- 2.6 demonstrate entry-level job skills for image manipulation.

# 3. <u>METHODS OF INSTRUCTION</u>

- 3.3 Roundtable discussion/critiques with students

# 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Class lectures over the pertinent information and principles with follow along demonstration
- 4.2 Reviewing and discussing professional examples of images
- 4.3 Reading assignments material in text
- 4.4 Lab projects and exercises exemplifying the type of graphics work being discussed

### 6. <u>STUDENT RESPONSIBILITIES</u>
