ARIZONA WESTERN COLLEGE SYLLABUS

GRA 201 INTERACTIVITY AND GRAPHICS Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: GRA 104

COURSE DESCRIPTION

This course focuses on utilizing multimedia authoring software to create onscreen interactive graphic content presentations for diverse delivery systems such as interactive kiosks, games, internet sites, or educational CD-Roms.

1. COURSE GOAL

Comprehend and design basic interactive projects, which aspire to professional quality and to give the student a working knowledge of a specific multimedia authoring software package.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify the basic components of the multimedia authoring application interface.
- 2.2 describe and employ basic principles of onscreen composition.
- 2.3 demonstrate basic entry-level job skills in the use of an industry standard multimedia authoring software package.
- 2.4 identify the basic structure used for scripting/programming shortcuts within the application.
- 2.5 produce a project, which combines images, text, sound, and animation.
- 2.6 produce both linear and non-linear presentation.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Lecture by the Professor
- 3.2 Demonstrations on projected Instructional station
- 3.3 Roundtable discussion with students
- 3.4 Frequent reference to design examples on the Web and on CD-Rom

4. LEARNING ACTIVITIES

- 4.2 Reviewing and discussing professional examples of various publication types
- 4.3 Reading assignments
- 4.4 Lab tutorials and exercises
- 4.5 Class follow-along demonstrations
