GRA 203 3D MODELLING AND SURFACING

Credit Hours: 4 Lec 3 Lab 2

PREREQUISITE: GRA 104

COURSE DESCRIPTION

This course focuses on basic concepts of three-dimensional graphics grounded in Cartesian geometry. Special emphasis will be on modeling, texturing, lighting and still rendering.

1. COURSE GOAL

Comprehend and design 3D modeled graphics with the use of professional industry standard software.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the use of primitives in 3D geometry.
- 2.2 perform various methods of 3D form creation and modification, such as lathing, sweeping, extruding, and skinning.
- 2.3 transform and edit existing models.
- 2.4 identify the purpose of and manage alternate views of an object.
- 2.5 produce a project incorporating world creation/scene design.
- 2.6 demonstrate and describe Boolean functions.

3. METHODS OF INSTRUCTION

- 3.1 Lecture by the Professor
- 3.2 Demonstration on projected Instructional station
- 3.3 Roundtable discussion with students
- 3.4 Frequent reference to design examples on the Web and on CD-Rom

4. LEARNING ACTIVITIES

- 4.1 Class lectures over the pertinent information and procedures
- 4.2 Reviewing and discussing professional examples of various types
- 4.3 Reading assignments
- 4.4 Lab tutorials and exercises
- 4.5 Class follow-along demos
- 4.6 Research the design process on specific projects
- 4.7 Complete quizzes and test over basic concepts of the class
- 4.8 Complete several projects to Professor's stated criteria
