GRA 204 ADVANCED 3D GRAPHICS Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>2</u>

PREREQUISITE: GRA 203

COURSE DESCRIPTION

This course focuses on intermediate concepts of three-dimensional graphics. Special emphasis will be on animation of the 3D objects and environment.

1 <u>COURSE GOAL</u>

Comprehend and design 3D modeled graphics with the use of professional industry standard software.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 produce a 3D figure with bones.
- 2.2 create a figure-based animation with the use of inverse kinematics.
- 2.3 define and avoid the appearance of clipping in their project.
- 2.4 produce a project with an animated scene or backdrop.
- 2.5 produce a project with animated lighting changes.
- 2.6 identify the basic control for animation within the application interface.
- 2.7 articulate the five "C's" of cinematography as relate to a class project.
- 2.8 articulate the limitations of web-delivered animation and produce a project, which is properly web-ready.
