ARIZONA WESTERN COLLEGE SYLLABUS

GRA 206 PORFOLIO AND CAREER MANAGEMENT Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: GRA 203

COURSE DESCRIPTION

This course focuses on preparing the student for one of two outcomes: continuation in a four-year graphics program or securing entry-level employment. Special emphasis will be placed on preparing a professional level portfolio and researching the job market.

1 <u>COURSE GOAL</u>

Achieve adequate preparation to represent their talents and occupational skillset for entry-level work.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 present a portfolio of their work for review.
- 2.2 constructively critique other's work and their own for strength of presentation and image quality.
- 2.3 present a current resume that reflects their skillset for potential employers.
- 2.4 identify current job markets in and beyond Yuma.
- 2.5 write a professional cover letter for job applications.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Lecture by the Professor
- 3.2 Demonstrations on projected instructional station
- 3.3 Roundtable discussion with students
- 3.4 Frequent reference to professional design examples

6. <u>STUDENT RESPONSIBILITIES</u>
