GST 104 Cartographic Design

Credit Hours: 2 Lec 2 Lab 1

PREREQUISITE: GST 101

COURSE DESCRIPTION

This course introduces fundamental cartographic concepts.

1. COURSE GOAL

- 1.1 Acquaint students with basic concepts of cartography as graphical means of communication.
- 1.2 Develop skills in map design, reading, analysis and interpretation.
- 1.3 Promote the principles of cartographic ethics and use acquired knowledge and skills adequately and responsibly in private, professional, and public life.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 categorize and describe different types of maps (thematic, reference...) and be able to give examples of how they are used.
- 2.2 describe the components of a map (map elements).
- 2.3 employ an appropriate geographic referencing system (datum, projection, coordinate system) for a given purpose.
- 2.4 select and apply ethical and appropriate data model, map scale, map elements, symbolization and color to produce maps that effectively communicate quantitative and qualitative geographic data.
- 2.5 design professional quality maps, including map elements such as text, graphs, charts and diagrams, employing cartographic principles.
- 2.6 produce maps and related products in a variety of formats (hardcopy, digital and web).
- 2.7 critique maps for appropriate use of cartographic design principles.

6. STUDENT RESPONSIBILITIES
