COURSE DESCRIPTION

Essential skills for caregiving at live-in facility, home health care and direct care worker

1. <u>COURSE GOAL</u>

Efficient practice of essential skills for health care aide.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, the student will be able to:

- 2.1 Identify and explain the role of a health care aide.
- 2.2 Demonstrate interpersonal skills that include; effective communication skills, recording and reporting, and confidentiality
- 2.3 Describe and demonstrate working with diverse populations; including elderly, children, well baby, mentally ill, developmental and/or physical disabilities and cultural differences
- 2.4 Describe the importance of nutrition and meal preparation
- 2.5 Describe safety and injury prevention measures
- 2.6 Demonstrate personal care skills
- 2.7 Demonstrate skills in special equipment used by clients
- 2.8 Demonstrate assisting with self-administration of medication

6. <u>STUDENT RESPONSIBILITIES</u>

- Initiating contact with a faculty member to ask a question about the academic subject studied in the course
