## HLS 101 INTRODUCTION TO HOMELAND SECURITY

Credit Hours: 3 Lec: 3

PREREQUISITE: ENG 80 or higher

## **COURSE DESCRIPTION**

Introduction to current public management policies and issues relevant to the security of the United States. The course relies upon theories, concepts and case studies to explore the challenges facing organizations which are part of protecting the security of our homeland.

- 1.2 Describe the role of federal, state, local, and non-profit organizations in responding to natural or man-made disasters.
- 1.3 Discuss the history of homeland security and the "War on Terror."

- develop a basic conceptual framework for thinking about protection of the homeland 2.1 security of the United States.
- 2.2 understand the history of homeland security as it evolved from the fields of civil defense, emergency preparedness, and traditional intelligence studies.

- 2.4 describe the organizations involved in homeland security, how they are organized, how they interrelate, and their specific roles. - 2.5 interpret, analyze, evaluate and make inferences of ill-defined homeland security issues and problems.
- explain your understanding of the hosts of threats and hazards (natural or manmade) 2.6 which threaten the safety and security of our way of life.
