COURSE DESCRIPTION

Use of print and electronic media to locate, read, and interpret public documents, statutes, administrative regulations, and cases from county, state, and federal jurisdictions.

6. <u>STUDENT RESPONSIBILITIES</u>

- Initiating contact with a faculty member to ask a question about the academic subject studied in the course
