COURSE DESCRIPTION

- 2.11 explain private controls on real estate.
- 2.12 explain public controls on real estate.
- 2.13 analyze the legal implications of the landlord-tenant relationship.
- 2.14 describe the tax consequences of owning real property.
- 2.15 describe the duties, powers, and liabilities of a real estate broker.
- 2.16 identify the legal issues presented for attorneys and paralegals in real estate law.
