# LAS 217 FAMILY LAW

### PREREQUISITE: None

#### COURSE DESCRIPTION

Legal analysis of marriage, dissolution of marriage, parental rights and duties, pleading and practice.

## 1. <u>COURSE GOAL</u>

Develop a basic knowledge of family law.

### 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 explain the requirements for a valid marriage in the state of Arizona.
- 2.2 differentiate among the rights and reciprocal obligations of spouses, parents, and children.
- 2.3 explain the concept and applications of community property law in Arizona.
- 2.4 describe the ethical problems that arise in domestic relations cases.
- 2.5 describe the different forms of contracts between spouses.
- 2.6 interpret the complex term "jurisdiction".
- 2.7 describe and compare the different types of injunctive relief.
- 2.8 compare no-fault divorce and its alternatives: legal separation and annulment.
- 2.9 describe and explain the importance and many functions of conciliation court.
- 2.10 identify and explain the authority and procedure for child custody and child support matters.
