#### **COURSE DESCRIPTION**

Word processing skills, litigation support systems, presentation programs, billing systems, and trial electronic software for the law office.

### 1. COURSE GOAL

Develop basic knowledge of computerized applications used in the legal field.

- 2.1 describe the ethical issues unique to the use of computers in the law office.
- 2.2 organize and prepare exhibits for an electronic trial, arbitration, or mediation using a trial presentation software program.

- 2.4 prepare the structure of common legal documents using a word processor on a personal computer.
- 2.5 manage information for several matters, persons, and events with varying relationships to the firm using a computerized docket control and calendaring systems.
- 2.6 manage billing activity using a computerized billing system.
- 2.7 use an integrated litigation support program.
