LGS 103 FREIGHT CLAIMS AND CONTRACTS Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: None

COURSE DESCRIPTION

Loss avoidance procedures, claim preparation, filing procedures, dispute resolution and other considerations involved in the drafting and negotiations of freight and logistics contracts. Legal and regulatory requirements applicable to contracts for product transportation are included.

1. COURSE GOAL

Understand basics of freight claims and contracts.

- 2.7 analyze types of freight and logistics contracts and their provisions.
- 2.8 evaluate freight and logistics contract provisions.
