LMT 271 ADVANCED ANATOMY AND MOVEMENT

Credit Hours: 2 Lec 1 Lab 2

PREREQUISITES: Massage Therapy Certification eligibility for AZ State license; instructor permission required

COREQUISITE: LMT 270

COURSE DESCRIPTION

A study of deep muscle and other soft tissue layers, anatomy trains, and external body movement (joint, bone and muscle).

1. COURSE GOAL

Identify and describe components of external body movement and structures affected by therapeutic massage and bodywork treatments. Explain physiological and psychological effects of soft tissue manipulation.
