PREREQUISITES: Arizona State license; instructor permission required

COURSE DESCRIPTION

Clinical experience in a professional setting with focus on advanced techniques and specialty exploration.

1. COURSE GOAL

Apply skills learned in Bodywork Mastery courses in a clinical setting.

2. OUTCOMES

Upon satisfactory completion of this course, the student will be able to:

- 2.1 conduct a complete medical history review to assess presenting conditions.
- 2.2 explain effects of dimensional massage therapy.
- 2.3 perform dimensional massage therapy protocols.
- 2.4 demonstrate on-going skill development based on feedback and evaluations.
- 2.5 identify specialty interests for exploration.
- 2.6 develop a minimum of three personal learning objectives to be achieved through clinic practice.
- 2.7 achieve personal learning objectives.
- 2.8 describe scope of practice for each identified specialty interest.
