PREREQUISITE: None

COURSE DESCRIPTION

Introduction to the masonry industry, basic chemicals related to the masonry industry, safety practices, job planning, and current masonry opportunities.

1. COURSE GOAL

Demonstrate an understanding of the masonry industry and how to apply OSHA rules and regulations on the job site.

6. STUDENT RESPONSIBILITIES
