COURSE DESCRIPTION

Introduction to algebra with an accelerated review of arithmetic skills.

 - 2.1.5 convert between fractions, decimals and percents.
 - 2.1.6 convert units of measure within the metric and U.S. systems.
 - 2.1.7 use given formulas to find perimeter, circumference, area and volume.
 - 2.1.8 solve application problems requiring the skills listed above.
- 2.2 use basic algebra skills to:
 - 2.2.1 add, subtract, multiply and divide signed numbers.
 - 2.2.2 use exponent notation and evaluate numbers with exponents.
 - 2.2.3 use a variable to represent an unknown value.
 - 2.2.4 use the order of operations to evaluate expressions.
 - 2.2.5 use the Addition Property of Equality to solve equations with one variable.
 - 2.2.6 use the Multiplication Property of Equality to solve equations with one variable.
 - 2.2.7 solve application problems requiring the skills listed above.
