### MATH 121 INTERMEDIATE ALGEBRA Credit Hours: <u>4</u> Lec <u>4</u>

# PREREQUISITE: None

## COURSE DESCRIPTION

Logical development of the laws of algebra, factoring linear equations, simultaneous equations, functions and graphs, exponents and radicals, quadratic equations.

## 1. <u>COURSE GOAL</u>

Develop an understanding of foundational concepts, reasoning, and skills in intermediate algebra.

Upon satisfactory completion of this course, students will be able to:

2.1 - Identify a polynomial by degree and number of terms and use this to determine and apply the appropriate method of factoring.

2.2 - Solve absolute value equations and inequalities in one variable.

2.3 - Analyze a function using algebraic or graphical methods to determine the domain and range of the function.

2.4 - Demonstrate algebraic operations in simplifying rational expressions.

2.5 - Solve equations containing rational expressions.

2.6 - Demonstrate algebraic operations in simplifying expressions containing radicals and rational exponents.
