MAT 150 COLLEGE ALGEBRA WITH REVIEW

Credit Hours 5 Lec 5

PREREQUISITE: None

NOTE: Credit cannot be received in both MAT 150 and MAT 151 (or MAT 187)

COURSE DESCRIPTION

Extension and further development of algebra, with an emphasis on functions - including linear, quadratic, rational, radical, exponential and logarithmic. Other topics include function transformations, regression analysis, inequalities, absolute values, systems of equations, matrices, sequences, and series.

1. COURSE GOALS

- 1.1 Gain an understanding of the algebra concepts mentioned in the catalog description.
- 1.2 Be able to apply these algebra concepts to real world applications.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Solve and graph linear equations and inequalities.
- 2.2 Solve and graph quadratic equations and inequalities.
- 2.3 Solve and graph rational equations and inequalities.
- 2.4 Analyze functions and their transformations.
- 2.5 Solve and graph logarithmic and exponential equations.
- 2.6 Solve applied problems involving linear, quadratic, logarithmic and exponential functions.
- 2.7 Perform matrix algebra and use matrices to solve systems of equations.
- 2.8 Find the general term of a sequence and the sum of a series.

7. STUDENT RESPONSIBILITIES
