MAT 183 PLANE TRIGONOMETRY/GE

Credit Hours: 2 Lec 2

PREREQUISITE: MAT 150 or 151 COREQUISITE: MAT 150 or 151

### COURSE DESCRIPTION

A study of trigonometric functions, equations, identities, and inverse functions, and solutions of right and oblique triangles.

  - 2.1.3 solve right triangle involving special angles of 30°, 45°, 60°, and 90°.
- 2.2 determine the value of trigonometric functions of general angles.
- 2.3 graph trigonometric functions.
- 2.4 verify and apply trigonometric identities.
- 2.5 evaluate inverse trigonometric functions.
- 2.6 solve trigonometric equations.
- 2.7 solve application problems.
- 2.8 use vectors.
