MAT 270 APPLIED STATISTICS/GE

Credit Hours: 4 Lec 3 Lab 2 MAT 1160

PREREQUISITE: MAT 142 or higher approved math course

COURSE DESCRIPTION

Introduces descriptive and inferential statistics such as graphical and quantitative description of data, discrete probability distributions, continuous probability distributions, one- and multi-sample hypothesis tests, confidence intervals, correlation, simple linear regression, and analysis of variance.

1. COURSE GOAL

This course provides the student with an introduction into statistics. Statistical methods and techniques will be developed and applied to practical problems involving applications to social, biological and environmental sciences.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 formulate and solve basic concepts of probability.
- 2.2 descriptively analyze a set of data.
- 2.3 appraise the importance of random variables and random sampling when obtaining samples for statistical inference.
- 2.4 make inferences based on probability distributions.
- 2.5 employ techniques of linear regression to model practical applications.
- 2.6 draw conclusions based on hypothesis testing theory.
