MDA 121 MEDICAL TECHNICIAN

Credit Hours: 6 Lec 4, Lab 4

PREREQUISITES: MDA 120

COURSE DESCRIPTION

An integrative approach to learning and developing the clinical procedural skills required to work in an ambulatory care setting. Includes the collection and documentation of vital signs, patient history, patient assessment, and partnering with patients to provide them with resources to achieve and maintain health. Also includes Clinical Laboratory Improvement Amendment (CLIA) waived testing, safety in medication administration, principles of nutrition, and legal and ethical considerations. Includes performing and documenting appropriate diagnostic measures, identifying pathology, and initiating treatment prescribed by a licensed provider. Also includes Exposure Control Plan, Blood Borne Pathogens Standard, Personal Protective Equipment (PPE), Environmental Protection and disposal of Chemical and Biological Waste based on Occupational Health and Safety Administration (OSHA) guidelines and Center for Disease Control (CDC) regulations to assure safety in the medical practice.

1. COURSE GOAL

- 1.1 Describe and apply Occupational Safety and Health Administration (OSHA) guidelines and current Center for Disease Control (CDC) regulations to assure safety and protection for patients and providers in the delivery of patient care in an ambulatory environment.
- 1.2 Identify pathologic conditions and perform prescribed diagnostic procedures to confirm presence or Absence of disease.
- 1.3 Assist with performing a physical examination to determine patient diagnosis and subsequent plan of Care.
- 1.4 Demonstrate clinical skills include, vital signs, blood pressure, temperature, pulse, respirations, Weight, height (infant length), and head circumference (infant), pulse oximetry readings.
- 1.5 Critical thinking, patient assessments, patient care, patient concerns regarding procedures.
- 1.6 Diagnostic Procedures including Electrocardiography, Venipuncture, Capillary puncture, Pulmonary Function testing.
- 1.7 Medication administration, oral medications, parenteral medication, injection sites, classifications Indications for use and desired affects, side effects, adverse reactions.
- 1.8 Rules of medication administration, Right patient, Right medication, Right dosage, Right route, Right Time, Right technique, and Right documentation.
- 1.9 Patient exam preparation, patient positioning, procedures and treatments, procedure supplies.
- 1.10 Perform specimen collection, quality control measures, and CLIA waived tests, Hematology, Chemistry, Urinalysis, Immunology, and Microbiology.
- 1.11 Describe dietary needs, dietary supplements, special diets, weight control, and diabetes, Cardiovascular disease, hypertension, cancer, lactose sensitivity, gluten-free, food allergies.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Perform critical-thinking skills to determine patient assessments and patient care.
- 2.2 Describe rules of medication administration.
- 2.3 Demonstrate clinical skills to obtain patient vitals, specimen collection, electrocardiograms.
- 2.4 Utilize learning resources to assist in patient in disease preventions and proper dietary needs.
- 2.5 Identify OSHA and CDC guidelines regulations in the medical setting and procedures.
- 2.6 Concepts of effective communication, patient coaching, health education, treatment plans.
- 2.7 Describe proper use of medical terminology and medical symbols in a health care setting.
- 2.8 Demonstrate safety techniques post exposure to blood, bodily fluids, and needle stick injuries.
- 2.9 Describe the legal implications of error in patient care, protocols, and procedures.
- 2.10 Effectively perform venipuncture, capillary punctures, and proper specimen collection Techniques.
