#### MDA 220 MEDICAL TECHNICIAN

6 credits, 4 lec, 4 lab

Prerequisite: Acceptance into Program Co-Requisite: MDA 240

## COURSE DESCRIPTION

Essential skills for medical assistant back office in a healthcare facility. Focus is on therapeutic skills and effective communication with clients, physicians, physician assistants, nurse practitioners, and other health care professionals. Communication skills for patient care assessment. The laboratory portion of the course simulates various situations, which teach the specific skills needed in a medical office.

Efficient practice of essential skills for administrative medical assisting.

- 2.1 Identify and explain the personal attributes required for successful communication with clients in the medical setting
- 2.2 Describe the role of the medical assistant in the healthcare setting
- 2.3 Identify and demonstrate basic principles of human needs as they relate to the care of the client in the medical setting
- 2.4 Demonstrate effectively application of theories in adaption and stress to the client in the medical setting
- 2.5 Define and correctly spell medical terminology
- 2.6 Correctly use standard medical abbreviations and symbols
- 2.7 Demonstrate and describe the basic skills required of the technical medical assistant
- 2.8 Demonstrate how to appropriately administer oral, injectable, and topical medications
- 2.9 Identify the role of the medical assistant in the medical specialties
- 2.10Demonstrate proficiency in specific laboratory skills and Clinical Laboratory Improvement Amendments (CLIA) office testing
- 2.11Demonstrate proficiency of technical skills in the lab

# 6. <u>STUDENT RESPONSIBILITIES</u>
