MDA 230 ESSENTIAL SCIENCES FOR MEDICAL ASSISTING 3 credits, 2 lec, 2 lab Co-requisite: MDA 220, MDA 240

COURSE DESCRIPTION

Overview of the structure and dynamics of the human body.

1. COURSE GOAL

Foundational study of human anatomy and physiology to include nutrition and health promotion, body structures and organ systems, pathophysiology, and disease processes.

- 1.1. Locate, label, and recognize the basic structures of the human body.
- 1.2. Summarize the functions of each organ system.
- 1.3. Relate normal physiological processes to a loss of homeostasis in each organ system.

1.4. Integrate an understanding of the functioning of the organs within each organ systems and the interactions of the body systems at the organismal level.

- 2.8 Analyze the role of DNA in controlling cell functions.
- 2.9 Classify the major chemical components of living things according to their structure and function.
- 2.10Characterize the basic structure and functions of the cell, the organelles, and all its parts.
