SYLLABUS

MUS 100L3 Private Music Lesson Level 3

Credit Hours: 0.5 cr./1.0 cr., 30/60 private music lesson per week

PREREQUISITE: MUS 100L2 and instructor permission required

COURSE DESCRIPTION

Third semester applied music individual lesson course designed to develop college-level performing skills on the student's instrument or voice. This course is required of music majors completing the A.A. in Music.

1. COURSE GOALS

The lessons provide one-on-one instruction with the goal of improving a student's technical and musical skills.

- 1.1 Prepare the student for transfer to a four-year university program.
- 1.2 Teach the etiquette for performing.
- 1.3 Teach the basic performance skills of breathing, good posture, and technical facility.
- 1.4 Build a basic repertoire of etudes, songs, and solo pieces for performance during auditions, recitals, juries, and, when appropriate, concert performance.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate an increasingly strong, secure (1) vocal technique, (2) instrumental embouchure, or (3) rudimental percussion technique.
- 2.2 demonstrate increasing clear and precise instrumental articulation or vocal diction.
- 2.3 control and refine tone production over the complete range of the instrument or voice.
- 2.4 demonstrate increasing technical proficiency and flexibility.
- 2.5 demonstrate increasingly accurate intonation.
- 2.6 demonstrate a more refined concept of musical interpretation and a more sophisticated knowledge of different musical styles.
- 2.7 perform prepared songs, scales, or other materials as directed by the instructor for the final exam (jury) to be heard in front of the music faculty.

3. METHODS OF INSTRUCTION

- 3.1 Demonstration/Lecture (one-on-one private lesson)
- 3.2 Aural and visual observation during lessons
- 3.3 Working with accompaniments and accompanists
- 3.4 Listening to and, if appropriate, emulating recordings
- 3.5 Required course materials will take the form of solos, method books, and etude books.

4. LEARNING ACTIVITIES

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
- 6.3 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.

  - Taking an exam, an interactive tutorial or computer-assisted instruction
  - Attending a study group that is assigned by the school
  - Participating in an online discussion about academic matters
  - Initiating contact with a faculty member to ask a question about the academic subject studied in the course
