#### **COURSE DESCRIPTION**

Beginning level of Civic Light Orchestra

# 1. <u>COURSE GOAL</u>

The Civic Light Orchestra performs light classical or popular music for major concerts. The orchestra also performs upon request for the college and other public functions

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 play and perform the finest light classical or popular orchestral literature at a beginning level.
- 2.2 execute the basic components of playing: tone quality, balance, blend, intonation, technique, rhythm, and ensemble awareness at a beginning level.
- sight-read music, possess good pitch, and understand the basics of melody, harmony, tonal balance, rhythm, bowing, technique, and ensemble skills at a beginning level.
- 2.4 perform in public at the highest possible level.
- 2.5 demonstrate familiarity with musical terms.
- 2.6 demonstrate an understanding of orchestral protocol in rehearsals and performances.

#### 3. METHODS OF INSTRUCTION

All instruction will follow standard rehearsal procedures

## 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Rehearsal of music by the full ensemble and by section
- 4.2 Sight reading
- 4.3 Perfection of intonation across the orchestral ensemble
- 4.4 Perfection of technical playing across the orchestral ensemble
- 4.5 Perfection of ensemble playing and awareness
- 4.6 Awareness of orchestral protocol during rehearsals and performances

## 5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, performances, assignments, and participation

#### 6. STUDENT RESPONSIBILITIES
