# PREREQUISITE:

# **COURSE DESCRIPTION**

Class Piano 1A will help students learn the fundamentals of piano playing.

# 1. COURSE GOAL

Give elementary instruction on the piano.

# 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 read in both treble and bass clefs.
- 2.2 execute major and minor five finger patterns.
- 2.3 play major and minor triads (broken and solid).
- 2.4 demonstrate knowledge and understanding of key signatures and relationships.
- 2.5 build arpeggios in major and minor keys through 7 sharps.
- 2.6 perform in various time-signatures.
- 2.7 demonstrate knowledge of sight-reading techniques.
- 2.8 demonstrate proficiency in the fingering patterns and techniques of major and minor scales and chords. Scales are extremely important. First year students must exhibit proficiency up through 5sharps and 5 flats, at least one octave, hands separately.
- 2.9 harmonize simple melodies with I/IV/V7 triads.
- 2.10 develop good practice habits.
