ARIZONA WESTERN COLLEGE SYLLABUS

MUS 123 PIANO 1A Credit Hours: 1cr, .6 lec/lab

PREREQUISITE: Instructor permission required

COURSE DESCRIPTION

This is an applied music individual half-hour per week lesson designed to develop beginning college-level performing skills on the piano. This course is required of music majors whose major instrument is the piano.

1. <u>COURSE GOALS</u>

- 1.1 Assess the skill level of the student during the first two weeks of lessons.
- 1.2 Select lesson materials that fit the skill level and needs of the student.
- 1.3 Implement drills that improve note reading skills, correct posture, and hand position.
- 1.4 Select appropriate literature at the discretion of the instructor.
- 1.5 Achieve an acceptable level of proficiency for an end-of-the-semester performance.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will:

- 2.1 perform beginning level technical exercises for muscular development and control.
- 2.2 perform beginning level major and minor scales, chords, arpeggios, and their fingerings.
- 2.3 develop sight reading skills.
- 2.4 develop good practice habits.
- 2.5 perform literature from the major historical periods.
- 2.6 perform publically.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Private one-on-one tutoring on the piano
- 3.2 Musical demonstrations and suggestions for improvement given by the instructor
- 3.3 The selecting of literature from major composers and major historical periods
- 3.4 The selecting of technical material from Czerny, Clementi, Cramer, etc.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Weekly lesson preparation
- 4.2 Sight reading exercises
- 4.3 Assigned materials practiced and completed
- 4.4 Recital and performance preparation

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
